- Agree to serve on at least one committee, attend committee meetings, and participate in the accomplishment of its objectives.
- Support Chamber activities by attending and/or promoting all events
- Promote membership in our Chamber by seeking and contacting prospective members and sharing the benefits of Chamber membership with them.
- Attend monthly board meetings
 - Article V, Section 6 of the By-Laws states:
 - *A Board member being absent three (3) consecutive regular meetings, except for good cause, shall be automatically dropped and another member shall be appointed to serve his/her unexpired term.*

The 2020 Board Member slate with potential Board member candidates will be presented to the membership for a vote at the November 14, 2019 Chamber meeting.
